

# AAACN Ambulatory Nursing Certification Review Course

The AAACN Ambulatory Care Nursing Certification Review Course can be given at your location. We will work closely with the practice facilities to customize the logistics of the course. We would welcome a phone conference to answer any further questions and determine a plan that would work best for your facility.

The course is a one-day event offering 8.0 contact hours. The course provides an overview of the potential content that may be tested on the American Nurses Credentialing Center (ANCC) ambulatory care nursing certification exam. It is a valuable opportunity to reinforce a nurse's knowledge of ambulatory care, identify weak areas, and learn new information. All topics are offered in an interactive, case problem-solving style to enhance critical thinking.

Course content is based on the American Nurses Credentialing Center (ANCC) Test Content Outline for the ambulatory care nursing certification exam. The target audience is the RN interested in taking the exam, nurses transitioning into ambulatory care, or those who need a refresher of the ambulatory care nursing specialty. Please note **this course does NOT grant certification** in ambulatory care nursing.

Number of participants: We recommend 60 or less participants. A minimum of 20 participants is required to host the course.

The AAACN fee to present the course is \$6,000. The fee includes two faculty honoraria, copyrighted course content, the provision of contact hours, continuing education certificates, a course handout to be duplicated by the host facility, and staff coordination.

If you choose to offer this course, AAACN agrees to provide the following:

- Two faculty to present the course, which is a one-day event offering 8.0 contact hours

- Contact hours and certificates

As the hosting site, your facility agrees to provide the following:

- \$6,000 fee to AAACN. A deposit of \$1,000 is required at the time this agreement is signed (no later than 45 days prior to course date). The balance will be invoiced, along with speaker expenses, following the course date. (Receipts will be provided.)
- Faculty expenses for **two** presenters, including hotel nights, airfare, meals, ground transportation, and miscellaneous travel expenses.
- Meeting room
- AV equipment including a microphone, **laptop computer with PowerPoint capability**, an LCD projector, and screen
- Food and beverage, if offered (recommended)
- Registration processing
- Promotion of the course
